Here is the information on the relevant Beh Sci 110 lessons for last Spring and this Fall. Note that M&D refers to the course text (Myers, David G., and C. Nathan DeWall, Psychology. 12th ed., MacMillan Learning, 2018.). The Halasz and Kaufman reading, which was removed this Fall, is an online introductory sociology text linked in the description below:

SPRING – 2021

- The course includes a block of lessons dedicated to a "social-cultural perspective" of the behavioral sciences. That is where the issues of race and racism come up.
- Prejudice and discrimination are discussed in one of the required textbook readings for Lesson 25. Relevant learning objectives for that lesson include:
 - Identify examples of prejudice, stereotypes, and discrimination.
 - Describe how explicit and implicit prejudice differ.
 - Describe some of the social, emotional, and cognitive roots of prejudice.
- Also on Lesson 25, cadets were asked to watch a video of the well-known "Brown-Eyes/Blue Eyes" demonstration. The video can be seen here: <https://www.youtube.com/watch?v=oGvoXeXCoUY>.
- On Lesson 26, we provided cadets with a very brief introduction to social structure and the sociological imagination. They read an introductory chapter from an online introductory sociology textbook (available at <https://www.sociologyexperiment.com/>) and also had them watch a short video on the "Sociological Imagination" (<https://www.youtube.com/watch?v=BINK6r1Wy78>). Relevant lesson objectives for that lesson included:
 - Define social structure and social status and describe how each influences our behavior.

- Distinguish between a personal trouble and a public issue.
- On Lesson 27, cadets read the Executive Summary of the Air Force's Racial Disparity Review (<https://www.af.mil/Portals/1/documents/ig/IRDR.pdf>). The relevant lesson objective for that lesson was:
 - Describe the key findings of the Air Force's Racial Disparity Review.

FALL – 2021

- The structure of the race and racism lesson remains largely unchanged.
- For Lesson 25, cadets still read the same textbook introduction to prejudice and discrimination and still watch the "Brown Eyes / Blue Eyes" video. The lesson objectives have been slightly revised to read as follows:
 - Define and identify examples of prejudice, stereotypes, and discrimination
 - Describe some of the social, emotional, and cognitive roots of prejudice.
 - Apply the content of Lesson 25 to the Brown Eyes / Blue Eyes video
- The material that was previously addressed in Lessons 26 & 27 has now been condensed into a single lesson (Lesson 26). Cadets are no longer reading the chapter from the on-line introductory sociology textbook, but will still be watching the "Sociological Imagination" video and reading the Executive Summary of the Racial Disparity Review.
