#### MEMORANDUM FOR SEE DISTRIBUTION

SUBJECT: Immediate Actions to Implement Guidance on DEIA Executive Orders

- 1. Reference: United States Office of Personnel Management (OPM) Memorandum, "Initial Guidance Regarding DEIA Executive Orders," January 21, 2025.
- 2. In accordance with the reference, ensure widest distribution of the enclosed ALARACT.
- 3. The reference requires several immediate actions by the Department of the Army. I appreciate that the Army has forces stationed around the globe, in nearly every time zone. We must expeditiously accomplish the following:
- a. Take down all outward-facing media of Diversity, Equity, Inclusion, and Accessibility (DEIA) offices immediately, but no later than 23 January 2025 at 1700 EST.
- b. Withdraw any final or pending documents, directives, orders, materials, and equity plans issued by the Department of the Army in response to the now-repealed Executive Order 14035, Diversity, Equity, Inclusion and Accessibility (DEIA) in the Federal Workforce (June 25, 2021) immediately, but no later than 23 January 2025 at 1700 EST.
- c. Cancel any DEIA related training immediately, but no later than 23 January 2025 at 1700 EST.
- 4. Report compliance with the requirements of paragraph 3 via the Enterprise Task Management Software System task HQDA-250122-RK38. Include what actions were taken to comply with this memorandum.
- 5. Army contracting offices are to report any DEIA-related contracts to the Office of the Assistant Secretary of the Army (Acquisition, Logistics, and Technology).
