SUBJECT: Interim Guidance for Executive Order 14222, "Implementing the President's 'Department of Government Efficiency' Cost Efficiency Initiative"

Reference: Executive Order 14222, "Implementing the President's 'Department of Government Efficiency' Cost Efficiency Initiative"

Purpose. The Department of the Air Force (DAF) is presently awaiting Guidance from the Office of the Secretary of Defense (OSD) on the interpretation, applicability and implementation of the Executive Order, *Implementing the President's "Department of Government Efficiency" Cost Efficiency Initiative*. This memo provides interim DAF guidance for military members and civilian employees who are presently on TDY, or traveling on PCS orders, or are scheduled to begin such travel soon.

Policy. Effective immediately, the DAF will limit travel to only essential purposes. Essential travel shall include travel for: (1) Professional Military Education, (2) military training or exercises, (3) training or education that directly supports or is a prerequisite for a military member or employee's assigned duties, (4) performance of an official duty or organizational mission requirement (e.g. negotiations, inspections, audits, etc.), (5) military members, civilian employees, and dependents on PCS orders, (6) travel by members of the Air Reserve Component to perform duty or for training, and (7) other travel as deemed essential by the first General Officer in the chain of command, or Senior Executive Service supervisor.

Where military members or civilian employees are properly authorized travel (approved travel orders for DAF operations) they must be compensated and are required to use the government travel card as set forth in law. The Executive Order, by its terms, is to be "implemented consistent with applicable law" and does not impair the "authority granted in law to an executive agency." Title 37 and the Joint Travel Regulation create a clear obligation to compensate employees for their approved official travel. The Travel and Transportation Reform Act requires the use of the travel card for official expenses. Moreover, the Executive Order authorizes the use of Credit Cards for the Department's "operations," which we interpret to include mission essential travel.
